Your compliance certification will appear in Section A of your Operations Specifications.

A copy of the Consortium Anti-Drug Plan, training materials, instructions, forms, collection kits, and all the other related materials will be shipped in a few days.

Your employees' names will be added to the random-drawing list of this consortium, which is required to make you legal under the regulations, based on the pre-employment tests you do for your "covered" employees. Your drug test forms for this purpose will be shipped to you in a few days. If you are coming to this Consortium from another consortium, or from having managed your own plan, you MUST send or fax us a list of the covered employees so that we can add them to the random pool.

Generally, the following guidelines will need to be observed regarding drug-testing within your company. This is by no means a complete list, and you will need to refer to the regulations and to the educational materials we will furnish you in order to get a complete understanding of what is required of you and of your company.

- 1. Pre-Employment Testing: All covered employees who have NOT had a pre-employment test will need to be pre-employment tested. Current employees who have had a pre-employment test DO NOT have to be tested.
- You will be advised if a covered employee is selected for a Random Test. DO NOT DO YOUR OWN RANDOM DRAWINGS.
- 3. Be sure to notify us if you add or remove an employee from the program. There is no charge for adding or removing employees.
- 4. YOU ARE REQUIRED TO OBTAIN CERTIFICATIONS from any companies or individuals who work on your aircraft, or who provide any other "covered" services for your company, that they are covered by an FAA-Approved Anti-Drug Plan. These certifications should be kept in a permanent file in your business office, and made available for inspection by FAA inspectors.

- (1) Antidrug and Alcohol Misuse Prevention Program inspections and enforcement activity will be conducted by the Drug Abatement Division. Questions regarding these programs should be directed to the Drug Abatement Division.
- (2) The certificate holder is responsible for updating this operations specification when any of the following changes occur:
 - (a) Location or phone number where the Antidrug and Alcohol Misuse Prevention Program Records are kept.
 - (b) If the certificate holder's number of safety-sensitive employees goes to 50 and above, or falls below 50 safety-sensitive employees.
- (3) The certificate holder with 50 or more employees performing a safety-sensitive function on January 1 of the calendar year must submit an annual report to the Drug Abatement Division of the FAA.
- (4) The certificate holder with fewer than 50 employees performing a safety-sensitive function on January 1 of any calendar year must submit an annual report upon request of the Administrator, as specified in the regulations.
